

For Lakeview, 2024 was a year of progress and meaningful impact. I'm proud to share some key highlights:

- **1,354 unique individuals** received services through Lakeview's programs.
- We increased our **total housing units** by over 4%, growing from 579 to 604 across the six counties we serve. An additional **20 supportive housing units** have been approved for 2025.
- Our **2024 Consumer Satisfaction Survey** scored Lakeview programs at **4.35 out of 5**, up from 4.28 in 2023—a reflection of our ongoing commitment to excellence.
- Lakeview was honored with the **2024 FLX Finest Gold Medal** for excellence in mental health services.
- **Prospect House**, our Residential Crisis Support Program, reopened in March 2024. Utilization and guest feedback have been overwhelmingly positive for this vital resource.
- We updated Lakeview's **Mission, Vision, and Values** to better reflect who we are, who we strive to be, and the principles that guide us forward.
- We said farewell to long-serving board members **Jason Feinberg** and **Tom Kime**, who concluded their terms with distinction, and welcomed **Lisa Wilson, Jamie Comenale, Jay DeChick and Olivia Savage** to the board.

The vision I was invited to share during my interview for Lakeview's CEO helped lay the foundation for the strategic progress we made throughout the year. Despite the challenges in our broader environment, I remain inspired by the measurable impact, everyday successes, and unwavering dedication of Lakeview's staff and those we serve. I want to extend my heartfelt thanks to every member of our team, our Board of Directors, and our community partners.

It is an honor to represent Lakeview and the life-changing work we do together. I look forward to all that we will accomplish in 2025 as we continue

"The Recovery Center Saved Me"

Matt earned his master's degree and taught sixth grade for several years in the Southern Tier of New York. However, his position as a reading teacher was his favorite job since he could work with a very small group of children allowing him to have more time to help one-on-one. His calm and gentle nature fit perfectly with that setting. He simply wanted to help the students to learn and feel better about themselves.

Unfortunately, the panic attacks and depression that Matt suffered caused him to move away from teaching. He ended up residing in facilities that would treat him as needed but it wasn't the best life for him. Eventually, Matt was able to move to a residential setting in a home with other individuals in similar circumstances. The community home, located in a quiet residential neighborhood in Geneva, was better than the treatment center but it wasn't enough for Matt. "I have a master's degree and never expected to find myself in this situation". One day, the community program director suggested he visit Lakeview's Recovery Center just to check it out; to see if he might enjoy the many social and recovery-oriented offerings available to him there.

Matt was very shy and quiet at first, but he kept returning to the Recovery Center because he knew he belonged there. Slowly and hesitantly, he started joining in: the men's group, chair yoga, coffee and chat, and eventually feeling comfortable enough to sign up for outings like Letchworth hiking in early Spring, Valentine's Day bowling, as well as the many center's in-house activities. He enjoys painting and art projects, which are a challenge for him because he is color blind.

Matt attends the Recovery Center as much as he is able, up to five times per week. Matt's growth has been swift because he belongs.



Lakeview Provided More in 2024:

- We added 40 new apartments in Ontario & Seneca Counties and were approved for five new apartments in Livingston County 2025
- We provided training to enhance our staff's professional and personal lives:
 - Mental Health First Aid
 - Safe Zone and Safe Talk Training
 - Breath-Body-Mind™
- We added ten new positions to our workforce including new management level positions
- We added four new members to our governing board of directors
- Lakeview staff exceeded expectations during the holiday season by providing donations of non-perishable food, personal items and winter clothing. The donations were brought to the food pan-
